**Subject: Release of Regulations and Syllabuses for ICSE and ISC Year 2027 Examination.**

Dear Principal,

This is to inform you that the Regulations and Syllabuses for ICSE & ISC Levels for the Examination Year 2027 are now available on the CISCE's official website ([www.cisce.org](http://www.cisce.org)) under the tab 'Library (Publications)' and can be accessed through the following links:

It must be noted that the following changes have been made in the **Regulations and Syllabuses** for both **ICSE and ISC Year 2027 Examination**:

1. The terms **Pass Certificate Awarded (PCA)** and **Pass Certificate Not Awarded (PCNA)** that denote the Result of a candidate in the Result document, are now replaced with the terms **Qualified** and **Not Qualified**, respectively.
2. The two result documents, i.e., **Statement of Marks** and **Pass Certificate**, earlier provided to the candidates with Pass Certificate Awarded (PCA) result, will now be merged into a single document titled **Pass Certificate cum Statement of Marks**, for candidates who qualify the Examination.
3. Candidates who do not qualify the ICSE/ISC Examination and their result is declared as **Not Qualified**, will be issued a document titled **Statement of Marks**.
4. Candidates who take the Supplementary Examination after qualifying ICSE / ISC Examination in the previous years, will be issued the result document titled **Supplementary Statement of Marks**.
5. Candidates may apply for the Duplicate copy of any / all the result document/s (as applicable):
  - (i) Duplicate Statement of Marks
  - (ii) Duplicate Pass Certificate cum Statement of Marks
  - (iii) Duplicate Supplementary Statement of Marks
6. The document ***Certifying Statement of Marks***, which was earlier issued to the candidates who applied for the issuance of a duplicate Pass Certificate, will cease to exist here on.

### 9. At the **ISC level**, the following specific changes have been highlighted in the **Regulations and Syllabuses for ISC Year 2027 Examination**:

- a) **Change in Pass Criteria** – To qualify the ISC Examination, a candidate will be required to attain pass standard in five or six subjects (instead of four or more subjects) which must include the subject English / Modern English and a pass grade in SUPW and Community Service as assessed internally by the School.
- b) **Total Number of Subjects to be offered** – All candidates for the Examination must enter for English/Modern English, with four or five elective subjects (instead of three, four or five elective subjects)
- c) The nomenclature for the subject **Accounts (858)** has been changed to **Accountancy (858)**.
- d) The following subject combinations are not permitted for the ISC Examination:
  - (i) English (801) with Modern English (891)
  - (ii) Physics (861) with Engineering Science (867)
  - (iii) Geometrical & Mechanical Drawing (869) with Geometrical & Building Drawing (870)
  - (iv) Mathematics (860) with Applied Mathematics (885)
  - (v) Robotics (884) with Artificial Intelligence (883)

Attention must be paid to:

- the subject Applied Mathematics (Subject Code 885) is suitable for candidates who wish to pursue a career in Humanities/ Commerce/ Economics/ Biosciences/ Social Sciences and other related fields.
- the subject Mathematics (Subject Code 860) is suitable for candidates who wish to pursue a career in Mathematics/ Physics/ Chemistry/ Engineering/ Architecture/ and other related fields.
